**ORDER**

The Modified CUCBCSS UG Regulations 2014 has been implemented vide paper read as (1) w.e.f. 2014 admissions for all UG Programmes under CUCBCSS Regular and SDE in the University of Calicut.

Vide paper read as (2), every student of UG Degree Programme shall have to work on a project of not less than 2 credits under the supervision of a faculty member as per the curriculum.

School of Distance Education, vide paper read as (3), requested to frame specific guidelines for conducting the Project Work in SDE as it is not mentioned in UG Regulation 2014.

Vide paper read as (4), the subcommittee of Steering Committee on CUCBCSS UG 2014 studied the matter and submitted the report to the Steering Committee.

The Steering Committee, vide paper read as (5), approved the report of the Subcommittee with modifications and the Vice Chancellor approved the same. A U.O has been issued accordingly, vide paper read as (6), regarding the Project Work of students of CUCBCSS UG 2014 under SDE as detailed below:

- Every student of UG Programme under SDE (CUCBCSS 2014) shall have to work on a Project of not less than 2 credits.
- Board of Studies concerned shall provide directions for the Project work.

- The examiner will evaluate the Project Report and award marks both for external and internal components. The external marks will be awarded based on the content and findings/suggestions of the report while the internal marks will be awarded based on the methodology adopted, lay out, reporting mechanism followed, bibliography, citations, scheme and arrangements of report etc.
- The Project Report shall be submitted to SDE before the commencement of the 6th semester examination.

Vide paper read as (7), the Steering Committee on CUCBCSS UG 2014 clarified that the above U.O is applicable to the Project Work of students under SDE, except for BBA and BMMC and regarding the subjects of BBA and BMMC, the existing rule is to be continued. It is also resolved that an amendment has to be made in the U.O read as (6) by making this clarification.

Vide paper read as (8), Vice Chancellor approved the minutes and ordered to implement the resolution of the Steering Committee, subject to ratification of Academic Council.

Sanction has, therefore, been accorded to revise the U.O, referred under paper read as (6), with the clarification that the resolution of Steering Committee referred under paper read as (5) is applicable to the Project Work of students under SDE, except for BBA and BMMC and regarding the Project Work of students of BBA and BMMC, under SDE, the existing rule is to be continued.

The U.O read as (6) is modified to that extent.

Orders are issued accordingly.
